Dear Fellow Gun Rights Supporter,

As you are painfully aware, our rights are under attack. Unfortunately not just at the national level but at the state and local level as well. The Nevada Firearms Coalition is the NRA State Association for Nevada. We are also members of the National Shooting Sports Foundation and the Civilian Marksmanship Program. Established in late 2011 our mission is to replace the defunct Nevada State Rifle and Pistol Association and to provide an effective voice for gun owners, shooting clubs, ranges and shooting industry in Nevada. Our purposes and objectives are displayed on our web page at [www.nvfac.org](http://www.nvfac.org).

We are writing you this letter for two reasons. The first is a request to join the Coalition as a corporate member and as an individual member if you have not already done so. You need to be represented and we need your support.

The second reason is to ask that you support our efforts to fund a lobbyist for this year's legislative session in Carson City. We are asking firearms dealers and retailers to contribute to our mutual fight. Three dealers have already donated \$4,000.00. Following their lead, we are requesting that if at all possible you donate \$1,000.00 to our effort.

Our primary issues this year are:

- To fight back and prevent state and local efforts to infringe on our rights
- To pass a statewide pre-emption law that will make one gun law for all of Nevada by eliminating county, city and town ordinances, as well as the Clark County handgun registration program.
- To enact a Castle Doctrine law that gives self-defense protection for civil as well as criminal consequences.
- To enact a Campus Carry law that will allow legal CCW carry on campus.
- To amend the CCW laws to permit all handguns rather than revolvers and semi-autos, eliminate the \$25.00 state fee and allow direct checks with NCIS, remove the Sheriff's and Chief's Association from the law as they are not an elected body.
- To support other pro-gun and pro-gun owner laws that may be initiated, and oppose any anti-gun laws that are put forth.
- We have sponsors and bill drafts already introduced for pre-emption, castle doctrine and campus carry.

With your donation we can have a full time lobbyist in Carson City representing the citizens of Nevada on a daily basis. This will be the first time in many, many years that Nevada gun owners have had their own voice and not been dependent on other groups to represent them.

Thank you for your consideration and prompt action.
